

Register of Members' Interests - General Notice of Registrable Interests

I, **Michael Stanley Eddowes** a member of **Redruth Town Council**, give notice that

EITHER

I have no registrable interests which are required to be declared under the Council's Code of Conduct, and I have put 'none' under all headings.

OR

I have set out below under the appropriate headings my interests which I am required to declare under the Council's Code of Conduct. I have put 'none' where I have no such interests under any heading.

(The form gives general guidance, and examples, but these are not comprehensive. The Council's Code of Conduct gives precise requirements.)

Employment, business, profession or vocation

- 1. You should show every employment, business, profession or vocation that you have to declare for income tax purposes.

- i. Give a short description of the nature of your job: for example, "Computer Operator" or 'Accountant'.*
- ii. Employees should give the name of their employer. If employed by a company, give the name of the company paying your wages or salary not that of the ultimate holding company.*

Sponsorship

- 2. You should declare the name of any person or body other than a Council of which you are a member who has made any payments to you in the last year towards your expenses as a councillor or towards your election expenses.

- i. You do not need to declare the amounts of any payments: only the name of the person or body making them.*

Contracts with the Council

- 3. You should describe all contracts between the Council of which you are a member, and either

- a. yourself; OR
- b. a company in which you have a beneficial interest or of which you are a remunerated director; OR
- c. a firm in which you are a partner.

- i. You need not say what the financial arrangements are, but should say for how long the contract is.*

Land in the area of the Council

- 4. Give the address or a brief description (by reference to a plan if necessary) to identify any land in the area of the Council in which you have a beneficial interest.
 - i. *If you live in the Council's area you should include your home under this heading as owner, lessee or tenant.*
 - ii. *A beneficial interest is where you have some proprietary interest for your own benefit.*
 - iii. *You should also include any property from which you receive rent, or of which you are the mortgagee.*
 - iv. *"Land" includes any buildings or parts of buildings.*

Licences to occupy land

- 5. Give the address or a brief description (by reference to a plan if necessary) to identify any land in the area of the Council which:
 - a. you (alone or jointly with others) have a right to occupy for 28 days or longer;
 - b. but do not own or have a tenancy of.
 - i. *Land" includes any buildings or parts of buildings*

Corporate tenancies

- 6. You should list any tenancies of property, where
 - a. the landlord is the Council of which you are a member; AND
 - b. the tenant is a company in which you have a beneficial interest or of which you are a remunerated director; OR
 - c. a firm in which you are a partner.

Interests in companies and securities

- 7. You should list the names of any companies, industrial and provident societies, or other bodies corporate that (to your knowledge) are active in the Council's area and in which you have a substantial interest. You do not need to show the extent of your interest.

You have a substantial interest if you own shares or other securities in the company with a nominal value of more than £25,000 or more than 1/100th of the issued shares or securities. If there are several classes of shares or securities, the fraction of 1/100th applies to any of those classes. These limits also apply to deposits with industrial and provident societies, and co-operative societies.

A company or body corporate is active in a Council's area if it has land or a place of business in that area.

The requirement also covers shares and securities held in the name of other people in which you have a beneficial interest.

Membership of other bodies

- 8. You should list any membership of or position of general control or management in any:-
 - a. body to which you have been appointed or nominated by the Council as its representative;
