#### JOB DESCRIPTION

### Responsible to:

**Job Purpose:** to provide an effective and efficient CCTV service in the Town Council's CCTV facility and monitor all cameras belonging to RTC and its partners; adhering to service level agreements at all times.

### **Duties & Responsibilities**

- To operate and monitor all systems within the control room in an effective and efficient manner, ensuring all work is undertaken in compliance with the operating procedures and data controls (GDPR)
- To work with all third-party partners such as the police and Cornwall Council via the approved communication methods to ensure the system is worked to its optimum.
- To respond appropriately to all CCTV incidents.
- To ensure all footage and records are kept to the highest standard so they are available as evidence in the event of judicial proceedings.
- To maintain the security and confidentiality of the CCTV Control Room by controlling access to visitors at all times.
- To report equipment failures to the maintenance contractor (Enerveo) and raise any areas of concern to the Strategic Projects Officer.
- To use Redruth Town Council IT packages effectively, updating and maintaining computerised systems to ensure the service performs successfully.
- To ensure a positive and flexible approach to the variety of tasks and work patterns within the role. This may include some working outside normal hours or at a different location.
- Manage information and operate in line with Redruth Town Council policies, procedures, and guidance on subjects such as Data protection, GDPR, Freedom of Information, confidentiality, information security

and sharing, the information lifecycle and data quality, to ensure compliance and efficient and effective information governance.

This outlines the duties required for the post of CCTV Operator in order to indicate the level of responsibility. It is not a comprehensive or exhaustive list, and duties may be varied from time to time which do not change the general character of the job or the level of responsibility.
